Rent to buy terms and condition

- Customer should states the option that suite their needs on a rent to buy option
- All the particulars of the customer such as FICA documents & contact details should accompany the agreement form.
- Customer is expected to pay amount of two months the remaining balance will be paid in the monthly bases in order to form the full payment option chosen
- Preferred payment methods should be a debit order or EFT. Cash payment amount is not allowed.
- In the instance of any breakdown the client will report to restore commercial refrigeration & we will weigh up the extent of the breakdown should we find that the breakdown is minor the mobile will be serviced at the expense of the company but if ever the breakdown is the cause of the customers negligence the customer will be asked to pay for the service.
- The customer is advised to notify Restore Refrigeration in case of any breakdown on the mobile
- In the event that the equipment is delivered to the customer at any premises which are rented by the customer, the customer shall be obliged to advise the Lessor of such premises that the equipment is owned by Restore Commercial Refrigeration & the equipment shall thereby not be subject to any landlord's hypothec
- The customer shall be obliged to have a comprehensive insurance cover in respect of the equipment for the period of rental and customer is liable for all risk of loss, damage, fire & scratch to the equipment from whatsoever cause may be arising from the time of delivery.
- Customer must always know that the trailer carry Restore Commercial Refrigeration log & will remains the property of the restore commercial refrigeration until the mobile trailer is fully paid.
- When the customer has honored his/ her rent to buy optional period the company will be obligated to major service the equipment before the ownership is transferred to the customer
- Customer is expected to fill up the agreement forms before a transaction take place

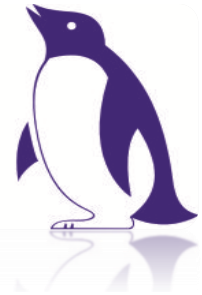
